Groups Split into Subcommittees: Smarter Sentencing and Familiar Faces

Familiar Faces:

Started with a discussion about the basic resources available in Santa Fe. There is a sense that resources are always changing and it's difficult to get current information.

Probation and Parole would like to discuss connecting with the Connect network, because probation cannot send people where individuals do not have the ability or the capacity to utilize the services that they are offered.

The Unite Us Platform allows for utilizers to consent to information sharing via one platform and facilitates an easier release of information. Probation would be able to see the services accessed for an individual if they were the referring organization for that individual. However, the platform does not allow those who are not working with that individual to view what services they are accessing.

Question: Is there another way to share information that might help facilitate diversion to services already being utilized by an individual?

There was a presentation at the Behavioral Health Summit some months ago that discussed an APP or an information sharing platform that allowed officers to divert to currently accessed services on contact with an individual. Will try to reach out to the organization that presented on it.

Some individuals who would be helpful to the conversation: Kate Field, and Nicole, Andres Mercado.

It would also be nice to get Edgewood Police Department involved in these meetings.

Probation and Parole would like to see more resources for post adjudication housing and employment.

The County Representatives spoke about the RISE program and how it's helping with Re-entry by setting up services before a person is released from detention.

The Connect Network currently has around 60 different programs with hub navigators who work together to get individuals what they need.

Some individuals need extra support because they do not have the cognitive functioning required to make it to appointments or to schedule appointments, they need to be guided through the process closely

Probation receives those individuals and stresses that sometimes it's difficult to assist them to that degree.
