Other Ideas: Craig Hay has seen the matrix program at the jail and the clients of the public defender have found the program to be helpful for their therapeutic needs while they are at the jail. Does not know where the funding for that program comes from but thinks that its wonderful and would like to see its continued existence. Spoke with a case worker at his office to gather further information and would like to see if there is a need for support to fund that program.

Elizabeth Peterson is a contract manager for the rise program. It is currently funded through Santa Fe County.

Mark says that the matrix program is completely funded as well.

Sophie wants to know how the BH intake person would differ from the currently available resources

Mark: Says the current BH assessments are for treatment for competency rather than linkages to the community. Most nonprofit agencies are Medicaid funded and the clients don't have Medicaid. It is costly to do the intake. In house, there are already behavioral health assessments. This current BH grant is set up for linage to the community.
