• Sentencing Commission Statutory Update and Grant Award Process: Jamie Goldberg & Douglas Carver

**David Carver:** Statutory changes were introduced in House Bill 175 including a change in Section 3 from May to Shall for membership criteria. Corrections was removed as a required member but is still welcome to be a member in the "other" category.

There was an addition to the grant purpose to develop and expand digitized records

There is now a dedicated fund for Grant Act appropriations that is a non-reverting fund.

Jamie Goldberg: There were many applications this year and not enough money.

6 Applications from the First Judicial, 18 Applications from the Second Judicial.

He encourages the CJCC to rank the grants in order of priority for the next round of funding.

Grants that might be funded by other sources are lower priority for the review committee.

Grant requests that can be fully funded are more likely to get chosen than those which could only be partially funded

Second round of funding is on October 20th

Nov 14<sup>th</sup> will be the meeting on grant decisions

Question: Is the Sentencing Commission focusing on data?

**Answer:** No its just one of the added priorities

**Question:** What about ranking?

**Answer:** We are hoping you work together by district rather than by county but you can rank by county if needed.

**Question:** What is the appetite for a program manager?

**Answer:** It is clearly on of the statutory purposes but there is a bit of a bias against funding staff. However, the commission understands the need to staff CJCC's

Would suggest that the entire district ask for the Coordinator if that is what they are interested in and to make it a 2 year application.

Would suggest that the CJCC work on hiring, show progress in staffing, be clear in the job posting that the position is not year funded.
