# Judge Biedscheid Grand Jury and CMO

- Districtwide changes to the grand jury procedure.
- There was a letter submitted to the Supreme Court requesting that they withdraw their order restricting the use of grand jury, and the subsequent order doing so.
- Will be a couple months before the grand jury changes are actually implemented. There are logistical challenges that need to be addressed first.
- Case management order that is modelled after the 8<sup>th</sup> judicial district and will go through the process of adopting that CMO as a local rule for the 1<sup>st</sup> judicial. There will be a public comment period.
- Question Kent Wahlquist: Is this the forum to talk about the changes and their impacts or another place or time?
  - Judge plans to hold a subsequent meeting with stakeholders. Those that wish to be included should let Kateri know. Didn't want the change to be a surprise so announced it ahead of time.
- Question Julie Ball: Were there prior meetings before the Supreme Court Order?
  - No, there were not. The change was motivated by a personal belief that the more autonomy the district has, and the less it is subject to these orders the better to give the district more flexibility.
- Question Julie Ball: Is there a template or local rule?
  - o The eighth judicial has a similar rule
  - o The local rule needs to be submitted before the end of the calendar year.
- Question Mary Carmack-Altwies, when are you anticipating that the two days a week begin?
  - o I'm not sure when this is going to start but I am going to have the stakeholder meeting regarding the logistics within the next six weeks or couple months.
  - o I felt that this district could figure this issue out.
- Kent Wahlquist: Will we continue to have one Thursday of the month until the changes are implemented?
  - The way that it is being held now will not be changed there isn't the same restrictions on what can be presented.

## **Grant Proposals for the October Session**

Asking for a Criminal Justice Coordinating Council Coordinator

- Would like to increase our capacity in the three county group and the subcommittees
- Would replace Kateri as a full time coordinator
- Idea comes from the National Standards for CJCC's, was presented at a statewide CJCC meeting in April
- The essential elements of a successful CJCC which include staffing and administration of the CJCC

- Recommends that the CJCC have a dedicated director separate from the entities who is accountable to the entire group
- Has a broader role including data analysis, annual reports, fiscal reports, facilitates the large overarching goal of the CJCC, spend a significant amount of time coordinating the agencies.
- This person is not an administrative assistant, this is a person with independent professional experience this person needs to be experienced in engaging with the entire criminal justice system.
- Some recommended qualifications: staying up to date on evidence based practices, have a science focused mind on designing research projects, be able to work with all sector public health, social services and the criminal justice system, the ability to conduct and evaluate research, integrate research and present a message to the CJCC, to engage with the public on policy implementation, someone who can do this work without supervision, someone who can actualize the goals of the group.
- Funding to staff and hire the CJCC coordinator to work with the three county group and three subcommittees
